This plan and its resulting procedures institute strict prevention measures to protect our workforce and Yukoners from the virus, while maintaining mine operations and the significant economic contributions we provide to the territory, which will help to lead us out of, and on the other side, of this crisis.

Victoria's COVID-19 Action Plan continues to be modified and updated as the situation evolves and continues to meet or exceed regulations and guidelines established and communicated by the Yukon's Chief Medical Officer of Health.

The plan's COVID-19 mitigation measures include:


- Employees returning to site from outside the Yukon will self-isolate in Whitehorse prior to traveling to site at the Eagle Gold Mine.
- A stop to all non-essential travel.
- All Yukon employees and contractors traveling to Eagle Gold Mine are required to complete a screening conducted by a third-party professional occupational health and safety services provider.
- All employees and contractors leaving the Eagle Gold Mine are required to complete this same screening prior to departing the site.
- All employees and contractors are instructed to practice physical distancing.
- Restricted and controlled access for all Victoria employees and contractors to all Yukon communities.



The property is accessible by road year-round and is connected to Yukon Energy Corp's electrical grid. The mine will be a significant contributor to Yukon employing 350 to 400 people.
